Smoking prevalence in Kuwait down, but not out

n World No Tobacco Day, which falls annually on 31 May, a look at the smoking prevalence in Kuwait reveals that while the trend is downward, having become passé among many adults, an increasing number of young people are getting addicted to smoking. In particular, new smoking products, such as flavored e-cigarettes, thrust on them by tobacco companies under the guise of being harmless products, are gaining favor with youth.

In early May, the Ministry of Health, in cooperation with other state agencies, launched an awareness campaign on a national

anti-smoking program aimed at protecting children from smoking. In a statement issued on the occasion, the ministry noted that the use of tobacco, both regular cigarettes and the newer vape or electronic cigarettes (e-cigarettes), among children was alarmingly on the rise. Surveys show that the use of e-cigarettes among children in the 13-15 age group was threefold higher than among adults.

Despite significant progress in reducing tobacco use among adults, the emergence of e-cigarettes and other new tobacco and nicotine products present a grave threat to youth, and to tobacco control initiatives, warned the World Health Organization (WHO) in a recent report. With half of all tobacco users dying prematurely, ensuring a lifetime of



profits for the tobacco industry relies heavily on recruiting new, young users, and hence its focus on young children.

"History is repeating itself, as the tobacco

industry tries to sell the same nicotine to our children in different packaging," warned WHO Director-General Dr. Tedros Ghebreyesus. Tobacco companies employ multiple tactics to gain the trust and interest of young people at an early age.

Through extensive advertising campaigns on popular social media and digital streaming platforms that are mostly unregulated, tobacco companies evade advertising regulations and unscrupulously target young people. In 1988, the WHO decided to observe World No Tobacco Day (WNTD) each year on 31 May, to focus global attention on the continued widespread prevalence of tobacco use, and its deleterious health impacts on people.

Canada, ICRC host insightful discussion on humanitarian aid

n 27 May, the Embassy of Canada, in collaboration with the International Committee of the Red Cross (ICRC), hosted an event entitled 'Keeping Humanity Alive' at the Official Residence of the Canadian ambassador.

The event, marking World Red Cross Day and the 75th anniversary of the Geneva Conventions, saw the participation of Regional Head of ICRC Delegation for the GCC, Mamadou Sow, thwho shared personal insights and experiences from the frontlines working in the humanitarian sector. Moderated by Canadian Ambassador H.E. Aliya Mawani, the dialogue spanned a range of pressing topics, including the operational scope of ICRC's work, the significant challenges it encounters amidst global crises such as the conflict in Gaza, and its role in upholding international humanitarian law.

A key focus of Mr. Sow's address was the ICRC's role as a neutral intermediary in facilitating recent prisoner exchanges between Saudi Arabia and Yemen, highlighting the complex operations and negotiations such endeavors entail. He emphasized the active essence of neutrality, stating, "Neutrality is not about standing by passively; it's about active engagement without taking sides, which allows us to deliver aid to those most in need amidst conflict."

The discussion also ventured into the evolving role of technology in modern warfare and the imperative for stronger legal



frameworks to regulate new technologies like autonomous weapons systems, ensuring they meet humanitarian standards and principles.

The event recognized Kuwait's significant role and its cooperation with international organizations like the ICRC. The enduring partnership between the ICRC, the Kuwait Ministry of Foreign Affairs, and the Kuwait Red Crescent Society has been instrumental, especially in global humanitarian operations and dialogues.

Ambassador Mawani, emphasized the strategic importance of these discussions: "It is our collective responsibility to strongly support humanitarian action.

Events like this are crucial in developing a

shared understanding of what that means and in strengthening the bonds between Canada, Kuwait, and international humanitarian entities that prioritize meeting the needs of vulnerable, conflict-affected populations I believe that full and frank dialogue is crucial as we reflect on our collective efforts and renew our commitment to addressing global humanitarian challenges together."

Reflecting on the evening, Mr. Sow shared a powerful message: "Tonight, we pulled back the curtain on the realities of humanitarian action, revealing the intense challenges and profound resilience encountered each day. Our mission transcends borders and politics — it's about preserving the flame of humanity in the



darkest of times. The support from nations like Canada and Kuwait is not just appreciated; it's vital in keeping this flame alive."

In a press statement released on 30 May, the Acting Director General of the Authority, Marzouq Al-Otaibi stated: "The authority's inspection teams will follow up on the implementation of the decision for three months, and they will conduct surprise inspection campaigns on work sites to detect any violations and record them, and take legal action against violators."

Over 30,000 Kuwaiti tourists visited Azerbaijan last year

• *H.E. Emil Karimo, Azerbaijan's ambassador to the country, stressed that there are good possibilities to increase the volume of trade exchange between the two countries, especially in the fields of food industries, tourism, light industries, and agriculture.*

E. Emil Karimo, Azerbaijan's ambassador to the country, revealed that the number of tourists who visited Azerbaijan last year exceeded 30,000 Kuwaiti tourists. He expressed pride in their choice of Azerbaijan as a tourist destination and their love for visiting it.

Ambassador Karimov mentioned in his speech during their celebration of Independence Day, in the presence of Deputy Foreign Minister Sheikh Jarrah Jaber Al-Ahmad and the Dean of the Diplomatic Corps, Ambassador of Tajikistan Zubaydullo Zubaydov, that there are direct flights between the two countries via Azerbaijan Airlines (Azal) and Kuwait Airways, with Al Jazeera also offering flights. He noted that the flight time takes less than two hours.

He invited the audience to visit Azerbaijan and explore its tourist attractions. He also stressed that there are good possibilities to increase the volume of trade exchange between the two countries, especially in the fields of food industries, tourism, light industries, and agriculture.

The ambassador pointed out that Kuwait and Azerbaijan are celebrating the thirtieth anniversary of the establishment of diplomatic relations this year. He mentioned the signing of the relevant diplomatic relations protocol on October 7, 1994. He also noted that the foundation for Azerbaijani-Kuwaiti relations was laid during the first meeting between the national leader of the Azerbaijani people, Heydar Aliyev, and His Highness the late Amir Sheikh Jaber Al-Ahmad at the Organization of Islamic Cooperation summit in Casablanca in 1994. Subsequently, the two leaders met in Copenhagen and New York in 1995.

He added that after the official visit of the President of the Republic of Azerbaijan, Ilham

Aliyev, to Kuwait in 2009, relations between the two countries entered a new phase. He explained that the relations between the two countries are close and friendly, particularly strong in the sectors of agriculture, tourism, and education.

Regarding the occasion, he said, "Today we celebrate National Independence Day. On May 28, 1918, the Azerbaijan Democratic Republic was declared for the first time in the Islamic world. State symbols, an elected parliament, and state institutes and universities were established. At the Paris Peace Conference in 1920, the Azerbaijan Democratic Republic was recognized, and foreign missions were approved in Azerbaijan. On October 18, 1991, Azerbaijan's independence was restored."

He added, "Azerbaijan is one of the ancient countries in the world with a rich history, culture, and famous cuisine, noting that his country has become the leading country in the Caucasus region today."

He continued, "The first years of independence were very difficult, marked by chaos, economic crisis, a very poor social situation, and civil war. Thanks to the efforts of the National Leader of the Azerbaijani People, Heydar Aliyev, who was elected President of our country in 1993, the crisis and chaos in our country ceased."

He further added, "Today, Azerbaijan is a victorious country that liberated its lands from an occupation that lasted 30 years under the leadership of the Supreme Commander, President Ilham Aliyev, thanks to the strength and heroism of our army."

He also added, "President Ilham Aliyev is successfully continuing the political legacy of the National Leader of the Azerbaijani People, Heydar Aliyev."

Croatia to enhance cooperation in food security with Kuwait

Indicating that obtaining a visa for Croatia, which is affiliated with the Schengen Area, is done through the visa center rather than the embassy, he added that Kuwaiti citizens are granted a five-year visa for the first time.

Speaking on the occasion,, Ambassador of the European Union, H.E. Anne Koistinen said, "Art has a unique ability to unite people across cultures and times, whether expressed through music, sculpture, painting, photography, theater, or in this case, the necktie, as it serves as a universal

Biometric fingerprinting to address dual nationality issue

The government is swiftly advancing the process of biometric fingerprinting in a bid to complete the Gulf biometric link project on schedule. The initiative to link biometric fingerprinting details among the Gulf countries will help detect all cases of dual nationality among the Gulf Cooperation Council (GCC) countries and automatically resolve the issue of dual nationality.

An informed source on the matter revealed that in the past, there were manipulations with names that confused the authorities and



to the fate of dual nationals — Anyone holding another nationality will have their Kuwaiti nationality immediately revoked.

There is no possibility of allowing the dual national to choose between nationalities, as the law confirms 'immediate withdrawal' of Kuwaiti nationality for dual nationals. The process of biometric linking between Kuwait and Saudi Arabia is understood to be nearing completion, especially after Kuwait finished the task of taking biometric fingerprints from citizens before the September 30 deadline announced by the Ministry of Interior.

If someone forges nationality using false names,

hindered the identification of dual nationals. But now, even if the entire quadruple name of the dual national between Kuwait and any other Gulf country is different, it will be revealed because the fingerprint does not lie, and its result is certainty that knows no doubt.

Biometric fingerprints are expected to help close the file on dual nationality easily and reveal dual citizens who may use different identities and documents in their movements between countries. This issue is a common Gulf concern due to the social, economic, and financial burdens it carries.

In Kuwait, the law is very clear with regard

the discovery will depend on the concerned party filing a complaint with the responsible authorities about the forgery and allegations. Accordingly, necessary investigations are carried out, and all legal measures are taken, starting with the loss of nationality and continuing through all stages of the criminal investigation and the resulting legal effects on the offender."

It is noteworthy that the Board of Directors of the Central Agency for Addressing the Situations of Illegal Residents met a few days ago under the chairmanship of the First Deputy Prime Minister, Minister of Defense, and Minister of Interior, Sheikh Fahd Al-Yousef.



Five Kuwaiti companies among the largest in MENA region

 $F^{\rm ive\,Kuwaiti\,companies\,have\,made\,it\,to\,the\,top\,positions\,on}$ MEED magazine's list of the 100 largest listed companies in the Middle East in terms of market capitalization. Kuwait Finance House (KFH) came in first place among Kuwaiti companies, followed by National Bank of Kuwait (NBK) in second, Boubyan Bank in third, Zain Group in fourth, and finally Mabanee Company in fifth place.

The report noted that the total market value of the top Kuwaiti companies reached \$84.4 billion, with Kuwait Finance House (KFH) occupying 11th place among the top 100 companies in the Middle East with a market capitalization of \$41.2 billion. National Bank of Kuwait (NBK) came in 18th place regionally with a market capitalization of \$24.3 billion, followed by Boubyan Bank in 49th place with a market capitalization of \$8.3 billion, then Zain Group in 57th place with a market capitalization of \$6.8 billion, and finally Mabanee Company in 99th place regionally with a market capitalization of \$3.8 billion.

In the Capital Governorate, the service is provided through the Abdul Rahman Abdul Maghani Center in Fayhaa area, and in Ahmadi Governorate through the Ahmadi Health Center on Tuesdays and Wednesdays of each week. In Mubarak Al-Kabeer Governorate, the service is provided through the Zahra Health Center.

"Work in these clinics will be during the morning hours during official working hours, and the "Travel Health Service" is provided throughout the year and on all days of the week, through the main clinic in the Public Health Department in Shuwaikh area," he said.

He pointed out that among the services provided by these clinics are health advice before travel and after returning to the country, providing information about prevalent diseases, safety and disease prevention information during trips, providing the necessary vaccinations to prevent infectious diseases according to the travel destination, in addition to providing preventive medicines such as malaria drugs.

MEW urges public to moderate electricity consumption

Ministry of Electricity, Water and Renewable Energy (MEW) warned that pressure on the electricity grid reached a record high on Friday, 31 May, putting additional pressure on the national electricity grid.

The record consumption for this period of the year exceeded 16,149 megawatts at 3pm on Friday, said the ministry in a statement. The ministry urged the public to moderate consumption, and switch off or limit the use of electrical appliances and equipment during peak hours in summer so as to conserve energy and reduce strain on the electricity grid.

PACI urges residents who change residence to update addresses

Public Authority for Civil Information (PACI) has invited approximately 5,500 individuals to review and update their residential addresses by submitting the necessary supporting documents within 30 days from 26 May.

The authority announced the cancellation of the residential addresses of 5,501 people based on information provided by the housing owner or due to the demolition of the building. The Authority called on those who changed their address to register their new addresses within 30 days, or be subject to the penalty stipulated in Article 33 of Law No. 32 of 1982, which is a fine of not more than KD100, depending on the number of people.

Mansour Al-Mizan, the Director General of the Authority, explained in a media statement that "changing the residential address invalidates the civil ID card, and its owner must visit the Authority's headquarters or one of its branches to update the card data by bringing the rental contract, the rent receipt, and an acknowledgment from the owner of the validity of the data." He noted that "the person concerned must bring the new house document if the owner of the card is the same

as the owner of the property."

Explaining that "the procedure can be done through the 'Sahel' application without visiting the authority, Al-Mizan pointed out that "if the authority learns that the address has been deleted, it sends a text message alert to the person concerned on the Sahel application. If the person does not respond, their civil card will be suspended and canceled from the 'My Identity' application, while remaining in Sahel so they can update their data. Additionally, their name will be published in the Official Gazette (Kuwait Today), and they will be given a specific period to comply with the law. If they still fail to respond, they will be referred to the judiciary."

Al-Mizan called on government and private agencies to ensure the validity of individuals' civil cards and "not to rely on the optical image of the card to conduct transactions or sign contracts, unless it is confirmed that the civil card is in 'Sahel' or 'My ID'."

Smoking prevalence in Kuwait down...

The day highlights endeavors by WHO to combat tobacco usage worldwide, as well as draw attention to the tobacco industry's insidious practices aimed at negating attempts to curtail smoking.

Latest health figures from WHO show that smoking kills more than eight million people each year, including an estimated 1.3 million non-smokers who are exposed to second-hand smoke. In 2020, approximately 22 percent of the global population used tobacco (36.7% of men and 7.8% of women).

To address the tobacco epidemic and implement policies that work towards tobacco cessation, in 2003, the World Health Assembly adopted the Framework Convention on Tobacco Control (FCTC). Although 90 percent of the world's population is now covered by the FCTC, it is estimated that less than half (49%) of the countries will meet the target of reducing tobacco use by 30 percent by 2025.

Kuwait ratified the WHO treaty in 2019, however, long before ratifying the WHO Protocol, the Ministry of Health (MoH) in Kuwait was pioneering tobacco cessation services as part of its tobacco control policies. It is noteworthy that the first tobacco cessation clinic in the region opened in Kuwait in the early 1980s. By 2003, there were cessation clinics in every governorate, providing medical assessment, nicotine replacement therapy and counseling.

The forward-thinking outlook by MoH has helped shape the state's tobacco control strategies that have resulted in a significant drop in smoking among the public. A health survey conducted by MoH, in cooperation with the WHO in 2014 showed that the average prevalence of smoking in Kuwait was 21.3 percent in the 18-69 age group — a significant drop from the 34 percent recorded in 1995 and the 27.2 percent observed in 2006. Nevertheless, given the country's relatively small population, the prevalence rate is considered high, and is an indicator of potential increase in heart disease and chronic non-communicable diseases in the future. Additionally, building on the 21.3 percent prevalence rate, the WHO predicts deaths attributable to smoking could be more than 345,000, or nearly half of the 670 000 smokers alive today.

cigarettes and all types of tobacco products and its necessities is also banned.

However, rigorous implementation of many of these laws has been lacking, especially with regard to new tobacco products such as e-cigarettes. Kuwait does not prohibit import or sale of e-cigarettes. Although in 2011, the General Administration of Customs had issued a ban on import of all e-cigarette products, the ban was withdrawn in 2016, allowing companies to import 'e-shishas and flavored products'.

In 2022, the government also decided to delay the imposition of an earlier planned 100 percent tariff on e-cigarettes and their flavors. The WHO stresses that governments seeking to reduce tobacco use and nicotine addiction should either ban e-cigarettes, also known as Electronic Nicotine Delivery Systems (ENDS) entirely or regulate them strictly as medicinal products or use the WHO's FCTC measures.

Tobacco companies invest enormous amounts of money in lobbying against tobacco control policies. and funds organizations that promote its interests. It uses different ways to spread misinformation, including through front groups and third parties, social media influencers, sponsored events, funding scientists and biased research. Despite tobacco killing over eight million people each year, the industry blatantly continues producing trillions of cigarettes that earn them billions of dollars in profit each year.

Meanwhile, a report by the WHO and the National Cancer Institute in the United States estimated the global economic burden of tobacco usage from healthcare costs and lost productivity at USD1.8 trillion annually, or around 1.8 percent of global GDP. Almost 40 percent of this cost occurs in low- and middle-income countries, (LMICs) where nearly 80 percent of the world's 1.3 billion tobacco smokers

In 1995, Kuwait introduced its Anti-Smoking Law 15/1995. Among others, the law prohibits the cultivation and importation of tobacco seed and seedlings, and the manufacture of all forms of cigarettes. The sale or presentation of cigarettes and other tobacco derivatives to people below the age of 21 is prohibited. live with limited access to tobacco cessation and treatment facilities.

Over the years, in response to irrefutable scientific evidence linking tobacco smoking to lung cancer and other illnesses, as well as growing public and political pressure to control tobacco usage, as well as multiple lawsuits filed against them, the tobacco industry began introducing new products camouflaged as being safer choices. Filtered and low-tar versions of cigarettes promised a 'healthier smoke'; vaping or e-cigarettes were claimed to be a 'safer alternative'; and the latest avatar of tobacco, nicotine pouches, is being touted as helping 'reduce harm'.

The tobacco industry's deceiving tactics highlight the urgent need for strong regulations to protect people, especially the young from a lifetime of harmful dependence. Youth organizations from around the world that participated in the Tenth Conference of the Parties to the WHO Framework Convention on Tobacco Control (COP10) in February, delivered a powerful message to policy makers — "Future generations will remember you as the ones who protected them, or the ones who failed them and put their lives in danger." sugar

World Bank predicts Gulf economies to grow 2.8 percent in 2024

The World Bank attributed Kuwait's robust economic performance to its expansive public financial policies, increasing oil production. and the successful full-scale operation of the Al-Zour refinery, which has a daily refining capacity of 615 thousand barrels.

he World Bank foresees Kuwait's economic growth rebounding to 2.8% in 2024, crediting expansive public financial policies, rising oil production, and the successful full-scale operation of the Al-Zour refinery, boasting a daily refining capacity of 615 thousand barrels.

In its report, the World Bank expected oil production in Kuwait to grow by 3.6 percent. Additionally, it forecasted a 2.1 percent growth in the non-oil sector for this year.

The bank mentioned that relatively high interest rates could constrain domestic consumption, thus hindering Kuwait's economic activity from reaching its full potential.

Moreover, continued political uncertainty may delay the implementation of new infrastructure projects and slow the pace of reform initiatives.

On the other hand, the World Bank report suggests a recovery in economic growth in the Gulf, reaching 2.8 percent in 2024 and 4.7 percent in 2025. This optimism stems from "regional prospects and the expected recovery in production." This includes not only oil, especially since OPEC+ is gradually liberalizing production quotas in the second half of 2024, but also the strong momentum of the non-oil economy, which is expected to continue expanding at a robust pace in the medium term. In this regard, the World Bank finds that Gulf countries' commitment to diversifying their economies highlights their strategic approach to enhancing resilience and achieving sustainable development during a period of global economic fluctuations.

Saudi Arabia: Regarding growth rates in the Gulf, the World Bank expects Saudi Arabia's real GDP to grow by 2.5 percent in 2024, driven primarily by strong non-oil private sector activities.

Forecasts indicate a growth of 4.8 percent, with the end of the period of voluntary cuts in oil production in the second guarter of 2024, and an expected gradual increase in production during the second half of 2024.

UAE: It is expected that the UAE's real GDP growth will accelerate to 3.9 percent in 2024, driven by OPEC+'s announcement of a significant increase in oil production in the second half of 2024 and the recovery of global economic activity.



The growth rate of oil production is expected to reach 5.8 percent in 2024, provided that non-oil output remains strong and continues to support economic growth, increasing by 3.2 percent. This growth is driven by the strong performance of the tourism, real estate, construction, transportation, and manufacturing sectors.

Qatar: Regarding Qatar, the World Bank expects real GDP growth to rise marginally in 2024, but it will remain at a modest level of 2.1 percent, with the non-oil sector growing strongly at 2.4 percent, driven by the growth of

the tourism sector.

Bahrain: It was stated that Bahrain's economic prospects depend on the future trends of the oil market and the acceleration of the pace of implementation of structural reforms. Estimates indicate that the growth rate will rise to 3.5 percent in 2024 with an increase in oil production, while the non-oil sector will remain the main engine of growth.



Meteorological expert Issa Ramadan stated that the current temperatures in the country are four to fivedegrees Celsius higher than usual.

Ramadan explained that this extreme heat wave is due to the Indian seasonal depression's influence on the region, coupled with hot winds blowing dryly through northern Kuwait's valleys and desert areas from Irag. These factors have significantly increased temperatures, with Ramadan attributing the abnormal heat waves to global climate changes and the impact of the El Niño phenomenon.

He likened the current situation to weather conditions experienced in the autumn of 1997 and the summer of 1998, noting that El Niño tends to increase heat waves during summers following unusually heavy winter and spring rains.

Also, heatwaves are arriving earlier than in past summer months due to the Indian seasonal depression.

Since the European Green Deal was introduced in 2019, European Commission President Ursula von der Leyen has touted it as the European Union's new economic-growth agenda. After all, while the strategy's core objective is climate-related — to reduce the EU's greenhouse-gas emissions to net-zero by 2050 — it aims to achieve that by modernizing the economy and fostering innovation. But not everyone is convinced.

In recent months, European drivers have complained about the EU's looming ban on the production and sale of cars with internal combustion engines, households have resisted plans to phase out gas boilers, and farmers have revolted against environmental regulations they view as overbearing. With the approach of next month's European Parliament elections, far-right parties are jostling to establish themselves as the official standard-bearers of this growing discontent and preparing to use any power they win to sabotage the green agenda. about who should bear the costs of climate action, both within and among countries. If those costs end up falling disproportionately on ordinary workers, let alone the poorest and most vulnerable communities, the transformation will exacerbate inequality, with potentially serious social and political knock-on effects. Fortunately, properly designed climate policies can avert that outcome and actually lead to greater social equality.

The European Green Deal has accounted for climate-justice considerations since the beginning. Advocates always knew that they would need to secure the political support of coal-intensive Poland, and they had not to be the most negatively affected by the green transition. Nor is it a coincidence that, while creating the first-ever carbon market for buildings and road transport, the European Commission established the Social Climate Fund, which is expected to mobilize at least \in 86.7 billion between 2026 and 2032 to compensate the most vulnerable groups for higher energy prices.

These policy initiatives reflect the advice one would find in the economic literature on carbon dividends. But they will prove insufficient to offset the profound distributional effects of climate policy, particularly as decarbonization accelerates and includes sectors that directly

And it should push for a 'Rural Green Deal' that supports small farmers while requiring the agri-food industry to transform its systems. While such EU-level action would not eliminate the distributional consequences of climate policy, it would help significantly.

The EU must also turn decarbonization into a real economic opportunity by developing a solid green industrial policy. This will require, first and foremost, revitalizing the 'boring' EU single-market agenda, in order to leverage the bloc's greatest asset — a huge shared market for goods, financial services, energy, workers, and ideas — to incentivize new investments in clean tech.

Interventions in specific technology areas will also be needed. Rather than mimic the broad-based US Inflation Reduction Act, the EU should make the most of its limited resources by delivering targeted support in areas where it already has a solid comparative advantage on which to build. While some incumbent industries might need support as they decarbonize, supporting breakthrough innovations should be the primary goal. The European Green Deal has come a long way since it was conceived five years ago. But if the EU is to achieve its 2030 climate goals and achieve net-zero emissions by 2050, it must act now to ensure that it can weather the inevitable political headwinds. A new green social contract and industrial policy can make all the difference.

The protesters make some legitimate points. The radical transformation that the European Green Deal entails raises difficult questions comparative advantage on which to build.



Building Resilience in the Developing World

In its latest World Economic Outlook, the International Monetary Fund notes in passing that the economic impact of COVID-19 on emerging and developing economies has been much more severe than previously thought. While GDP growth rates in the developed world have returned to their pre-pandemic trends, those of developing countries are even lower.

The economic scars of COVID-19 across the developing world, particularly large debt overhangs and insufficient investment in future growth, will remain visible for decades. And as environmental disasters become increasingly frequent and more severe, the pandemic might be a harbinger of future shocks. COVID-19 is not the last or the most virulent virus the world will face.

After all, pandemics are far from the only environmental threat disproportionately



affecting low-income countries. Climate change and biodiversity loss, together with antimicrobial resistance, air pollution, and lead poisoning, among others, all have the potential to act as significant drags on developing economies' growth.

To be sure, emerging and developing economies are still growing faster than their more developed counterparts. Over the past three decades, developing countries' share of global economic growth has nearly doubled to over 70 percent, but as extreme weather events, epidemics, and other natural disasters become more frequent, this may change. To prevent the gap between rich and poor countries from growing, we require a deeper understanding of developing economies' unique vulnerabilities, as well as more effective strategies to build resilience.

COVID-19 is a case in point. Despite the massive death toll, developed countries have been able to leverage their substantial fiscal and monetary resources, along with their access to vaccines, to minimize the pandemic's long-term economic impact. By contrast, the damage to emerging and developing countries has been more severe and is expected to last much longer than initially anticipated, reversing decades of progress and undermining their ability to achieve the United Nations Sustainable Development Goals (SDGs).

The financial risks associated with climate change can be both acute, triggered by extreme events such as storms and floods, and chronic, resulting from long-term shifts in weather patterns. Damage to physical assets, supply-chain disruptions, and reduced output pose significant threats to economic growth and development, especially in countries with mounting debt burdens and limited resources.

These risks inevitably affect the cost of capital. Ideally, capital should flow 'downhill' from capital-rich to capital-poor countries, where the potential social returns are higher. Since the 2008 global financial crisis, however, capital has tended to flow uphill, largely owing to perceived risks and weak institutions in merging and developing countries, as well as developed economies' monetary policies. The growing threat posed by pandemics and climate change are reinforcing these trends. This is happening despite steady improvements in macroeconomic policies across the developing world. A recent paper by Piroska Nagy Mohácsi and others suggests that in terms of transparency and accountability, central banks in developing countries have even surpassed the US Federal Reserve and the European Central Bank. During the 2008 crisis, and again during the pandemic, developing countries' central banks closely followed the policies of the Fed and ECB. But their postpandemic inflation forecasts have been more accurate, enabling them to respond faster to price increases. While these improvements have not significantly reduced the cost of capital, they may help address another, related problem. Most infrastructure investments needed to mitigate future pandemics and environmental shocks rely on technologies that are financed in dollars, yen, and euros but that generate revenues in local currencies. Improved macroeconomic management could make developing countries' currencies more attractive, reducing currency mismatches.

Climate adaptation and resilience efforts are more difficult to finance than mitigation measures, as developing countries often lack the necessary revenue streams to secure contracts. The newly created Pandemic Fund could help bridge some financing gaps by facilitating investments in pandemic prevention, preparedness, and response. But the Fund is not large enough to support the necessary climate adaptation and biodiversity restoration projects, underscoring the need for additional financing mechanisms.

Collective investments in resilience are particularly crucial for poor people who cannot afford personal protective measures like generators, air purifiers, air conditioners, and floodwalls. Using the case of mangroves in Indonesia, a recent study by the Asian Infrastructure Investment Bank shows that these trees protect economically vulnerable communities from tidal waves. But poor people are more likely to deplete mangroves as they use them for firewood and building materials and live in areas where local authorities have less capacity to maintain these vital ecosystems.

To build resilience, emerging and developing economies must also attract private and institutional capital. This requires the creation of markets that can accurately assess the value of lower carbon footprints and the impact of climate change. Multilateral development banks, in particular, can play a vital role in certifying such assessments. They also help in managing risks, mobilizing private investment, stabilizing capital flows, and creating new tools



Ideally, capital should flow 'downhill' from capital-rich to capitalpoor countries, where the potential social returns are higher. Since the





2008 global financial crisis, however, capital has tended to flow uphill.

for evaluating investments in adaptation and resilience.

Developing economies are already facing much tighter environmental constraints, with a limited global carbon budget and commitments to reverse biodiversity loss, than countries that achieved high-income status in the past. Strengthening resilience to future pandemics and environmental shocks will be crucial to preventing lower growth in emerging and developing economies, and thereby maintaining overall global growth.

Safe disposal of medication protects people, environment



A fely disposing of unwanted medication is vital to prevent their accidental use, or misuse by people. Discarded drugs can also harm the environment and pollute water resources. Some drugs can be very dangerous, or even fatal, for people who are not meant to take them, especially children and pets may be at risk of coming into contact with improperly stored or disposed of drugs.

A survey conducted several years back among pharmacists working in hospitals and polyclinics in Kuwait examined how they disposed of unwanted medications (UM) returned to them by the public. The survey also assessed the awareness of pharmacists about the impact of improper disposal on the environment, and whether they would agree to have their pharmacies as collection points for future take-back programs.

The survey found that the majority (73%) of pharmacists polled discarded returned medication by dropping them in the trash, while only 16 percent of respondents disposed of UMs according to the guidelines of the Ministry of Health (MoH). In addition, around 82 percent of respondents said they were aware that improper disposal causes damage to the environment and 88 percent of the pharmacists also agreed that government hospital pharmacies and polyclinics should serve as collection points for any take-back program.

On a related note, in 2022, the Healthy Cities Office of the Ministry of Health organized a campaign to evaluate the effectiveness of a 'take-back' campaign in promoting medication safety in Kuwait. The campaign also aimed to educate the public about the risks and hazards associated with storing expired and unused medications at home, emphasizing the potential for medication errors and drug-related harm from these products.. The campaign, which lasted over a period of one month, successfully engaged 405 households and collected 1005 kg of medication, comprising 7,648 items. An evaluation of the returned products revealed that painkillers comprised the largest group (18%) among the returned medications. This was followed by gastrointestinal drugs (12%), antibiotics and other anti-infective drugs (11%) and vitamins and dietary supplements (10%). Over half of the items returned during this campaign, 4,395 (57% of the total), originated from the Ministry of Health and 3,253 (43%) came from the private sector. The campaign found that 52 percent of items had expired, 24 were used but not expired, and 21 percent were unused but not expired. No information was available for 3 percent of the items Currently, the Ministry of Health in Kuwait lacks a dedicated collection service for the proper disposal of household medication. The campaign sought to provide a safe and controlled mechanism for the disposal of unused and expired drugs, through secure collection points at primary health care (PHC) centers on designated

collection days. The take-back campaign also served as a platform to raise public awareness about safely disposing unwanted medication, and the urgent need for the MoH to implement a 'take back' service

In many countries there are proper guidelines on how to safely dispose of medications, including pills, syringes, and inhalers. The best way to dispose of most medications is to take them back to an official drug takeback facility if available.

Properly disposing of used or unused needles and syringes helps prevent others from getting cuts or punctures. People can dispose of needles and syringes at home by placing used ones immediately into disposal containers meant for needles and other sharp objects (Sharps disposal containers are available in some pharmacies and healthcare centers).

Check with local trash removal services or healthcare facilities to find out what services are available to dispose of such containers. People can also flush certain dangerous drugs down the toilet to limit the risk of someone else using them or a pet consuming them.

Health experts and organizations involved in drug safety recommends immediately flushing away unused or expired medications with the following words in their names: benzhydrocodone, buprenorphine, fentanyl, hydrocodone, meperidine, hydromorphone, methadone, morphine, oxycodone, oxymorphone sodium oxybate, tapentadol.

They point out that the potential risk from these medications, some of which can be fatal if improperly used, outweigh the potential impact of flushing them away on the environment. Moreover, considerably more amounts of drug waste reaches the environment through waste water supplies, when medicines pass through the body and enter the waterways through urine, feces and other human expellations. In particular, used and unused fentanyl patches should be flushed immediately. Fentanyl patches, which are strong pain relievers administered through the skin, can harm anyone who has not received a prescription to use them. A significant amount of the drug remains in a patch after use, so it could harm anyone who picks it up by accident. The medication usually comes with instructions on flushing used and surplus patches safely.

Genetics could help predict high BP risk

Studies estimate that one in every three adults around the world has high blood pressure (BP), also known as hypertension. According to the World Health Organization (WHO) high blood pressure is responsible for 7.6 million deaths every year, or around 13 percent of total deaths around the world. Around 54 percent of stroke and 47 percent of coronary heart disease are attributable to high BP.

While certain unmodifiable risk factors, such as age, ethnicity, and some existing health conditions can increase a person's potential for developing hypertension, there are also a number of lifestyle changes — including losing weight, eating healthy, lowering salt intake, exercising, and not smoking — that can help reduce that risk.

Early detection, adequate treatment, and good control of high blood pressure can lower the risk of complications associated with hypertension. However, early detection of BP is difficult as high blood pressure does not cause any visible symptoms. Currently early diagnosis of high BP is limited to undergoing a screening for hypertension.

Now, researchers from Queen Mary University of London in the United Kingdom say that genetic signals could help doctors identify those at risk of developing high blood pressure early on in their lives.

For their study, researchers analyzed genetic data on more than one million individuals from the UK Biobank, the International Consortium for Blood Pressure, the United States Department of Veterans Affairs' Million Veteran Program, and Vanderbilt University Medical Center's biorepository.



The study identified 113 novel regions of the human genome, also known as genomic loci. They also found more than 2,000 independent genetic signals for blood pressure across all loci. They noted that although many genetic variants within the same 'locus' — a specifically defined region on a chromosome — will be similar, their study found many examples of 'loci,' which contain multiple, independent, distinct 'signals'. Blood pressure is a highly polygenic trait, meaning that it is influenced by thousands of different genetic variants, and each of these genetic variants will only have a small effect on increasing or decreasing blood pressure levels. However, if all the effects of all associated genetic variants are combined into one single aggregated risk score, which the researchers called a polygenic risk score, it could indicate larger effects on blood pressure.

Keep in mind the following tips when throwing away unused medication:

- Remove the medication from its packaging
- If possible, mix UM with any substance such as dirt, cat litter, or coffee grounds to deter children and animals from picking them up
- Take care not to crush any tablets or capsules
- Recycle the empty bottle or other packaging, taking care to obscure or remove any personal information first.

A polygenic risk score essentially gives each person a score, according to how many risk variants they carry. Knowing someone's genetic risk score would enable a doctor to know if the patient was in the high genetic risk group.

By using polygenic risk scores, scientists said they found that study participants with the highest genetic risk for hypertension have mean systolic blood pressure levels that are about 17 millimeters of mercury (mmHg) higher than those with the lowest genetic risk. The highest genetic risk group also has a seven-times likelihood of developing high blood pressure compared to those with the lowest genetic risk.

A main benefit in knowing genetic risk is that our genes are fixed at birth, so the genetic risk score is the same fixed value throughout life. Calculating people's genetic risk scores before middle-age, when generally other lifestyle risks tend to increase, doctors would be able to target patients at higher genetic risk and recommend earlier lifestyle or therapeutic interventions.

Early detection could help reduce blood pressure before it begins to impact health, and thereby lessen the risk of cardiovascular disease in future. Researchers believe that more knowledge about how genetics impact a person's blood pressure will ultimately help predict those at risk of high blood pressure in the future
